As for corporate clients this Tariff shall apply 15 days from the date it is published at a prominent place within the business premises of the Bank and on the web site of the Bank [www.apibank.rs](http://www.apibank.rs) i.e., shall be effective as of **January 28 2021**.

As for entrepreneurs this Tariff shall apply upon two months as of it's publishing at a prominent place within the business premises of the Bank and on the web site of the Bank [www.apibank.rs](http://www.apibank.rs) i.e., shall be effective as of **March 12 2021**.

On the date of this Tariff implementation, the Tariff for corporate clients and entrepreneurs adopted by the Executive Board Decision No. IO-173/2019 as of July 4<sup>th</sup>, 2019, ceases to be valid.
